A deposit of \$200.00 will reserve the rental and is refundable if notice of cancellation is given within fifteen days of the rental agreement. The remainder of the balance for the rental hall is required to be paid in full two weeks before the event.
PLEASE NOTE: If there is damage to the hall after your event, you will be charged a fee of \$100.00. NO GLITTER, CONFETTI, OR TAPE ON THE WALLS OR WOODWORK. Nothing hanging from the walls.
Stipulations to this agreement are located in the attachment and must be adhered to and signed by the Renter. Violations by the Renter of the stipulation could result in the termination of the contract and the forfeiture of the deposit.
